### Anti-Social Behaviour

Through our partnership working, in particular with Sussex Police and Neighbourhood Watch Association, plus routine monitoring of crime reporting websites for information about suspicious activity, people and vehicles we are able to understand and respond to emerging trends.

#### Crime

05/02 – We received a report of non-permanent criminal damage to an outside light that had been tampered with.

06/02 – We received a report of non-permanent criminal damage to an outside light that had been tampered with.

06/02 — We received a report of eggs being thrown at a property in Pevensey Road overnight causing the older resident considerable distress. We spoke to the resident's family and encouraged them to make a report of non-permanent criminal damage to Sussex Police. In the event that it happens again, multiple reports can change the offence options for the police if a suspect is identified.

12/02 - We received a report of the theft of an outside PIR light that had previously been tampered with.

19/02 – We intercepted two adult shoplifters and recovered stolen goods which were returned to the shop.

21/02 – We intercepted the same two adult shoplifters and again recovered stolen goods.

25/02 – We received further reports of two adult shoplifters and conducted an area search.

28/02 – We conducted an area search for two adult shop lifters that had been reported to us.

12/02 – We responded to a report of suspicious vehicles in a residential road parked up on a regular basis with engines running whilst the occupants from both cars were seen to come and go several times over a period of hours. We have passed the descriptions of the people and vehicle information to our local PCSO for further checks whilst we increase patrols in the area. This situation has now been resolved.

We conduct regular parking patrols at key times around our schools and there are a small number of drivers who require encouragement to park appropriately.

# Community engagement/events/meetings

15/02 – We held the first set up meeting for a friendship group for residents at Roundstone Park. The idea behind this is to tackle loneliness and to connect with like-minded people. The group has already organised their next meeting and we are hoping that more Roundstone residents will join the group.



19/02 – We attended the Welcome Club at The Ghyll with live music by Margaret Wilson and her harp.





20/02 – We held another SEN Journey Group at Beeson House. Our next session will be held on the 20 March 2025 in the Council Chamber at Beeson House. Representatives of the Aspens Charity are hoping to join us that day. Aspens provide support and care to children, families and adults across the South of England. Their services include registered care homes, supported living, community outreach, day services, including pathways to employment, children and young people's groups and support, specialist support - and free online support for families and carers.

26/02 – We attended the games afternoon club held at the Village Hall which gave us the opportunity to chat to residents about any concerns they had.

### **Patrols**

- We continue patrols of local businesses designed to disrupt shoplifting, ASB and improve engagement.
- We continue to provide high visibility patrols both on foot and in a liveried vehicle throughout the Parish.

05/02 – We carried out a joint patrol with Councillor Alex Jeffery and Hayley Timson, Office Manager for Castlewood School at school pick up time in order to discuss ongoing traffic management issues and to look for potential solutions to the risks posed to pupils by the number of vehicles and anti-social driving/parking. Our recommendations will be sent to West Sussex County Council for consideration.

05/02 – During our regular school patrol, a parent fell near the Texaco garage. Thankfully, local First Aid Trainer, Jenny Legg of 'Training Legs First Aid' was quickly on scene and although we offered assistance, she had it all under control. The patient was supported to safely complete her journey.

21/02 – We carried out a joint patrol with PCSO Cecil following a report of shoplifting that day.

# Older, Vulnerable People and Youth

We routinely conduct high visibility patrols at times and in areas often used by older residents to offer a reassuring presence plus cover areas previously connected with ASB in order to act as a deterrent. Throughout the month, we regularly visited the Southwater Youth Project and engaged with many young people.

We have continued our work with a number of vulnerable residents in the village making sure they have access to the support they need. This involves us having confidential conversations, identifying solutions and signposting residents to the most appropriate support network. We regularly do follow up visits to make sure that any support package is working effectively and to ensure that lines of communication remain open as situations can change quickly.

06/02 – We carried out a welfare check on a vulnerable person following a report of a cause for concern.

07/02 – We visited a vulnerable resident to discuss the option of a call blocker provided by Trading Standards.

21/02 – We conducted a visit to a vulnerable person who is feeling isolated and managed to set up a friendship circle for them.

### Cycling

12/02 & 14/02 – Whilst on patrol, we found an electric motorbike being ridden by a male whilst watched by two others. Each time we got close enough to engage with them, the bike was ridden off at speed to a new location. We liaised with our local PCSO who attended and conducted an area search for the group but they were not found.

### **Public Enquiries**

This month we responded to 19 enquiries from residents by phone, email or in person and where necessary, signposted them to the most appropriate support services. These enquires included welfare concerns for a number of residents, numerous reports of non-permanent criminal damage and a report of anti-social use of a mobility scooter.

#### Hazards

07/02 – We came across a vehicle that had broken down coming off the Hop Oast roundabout causing a hazard to other road users. We secured the area and waited with the driver until the Police arrived. Together with the PCSOs, we manged to move the vehicle to a safer location until the vehicle could be recovered.

24/02 – Whilst on patrol on Stakers Lane, we noted large amounts of dirty water flowing from the pumping station. We reported it to Southern Water as a priority hazard who promptly attended to address the issue.

28/02 – We reported overgrown vegetation on Southwater Street to West Sussex County Council.

11/02 – We had a meeting with our colleagues in HDC Community Development team to discuss funding/projects

26/02 – We attended the Steering Group meeting with Councillors Steve Lewis and Chris Pearce, as well as Neighbourhood Warden Supervisor Carol Boniface.
