Sadly, the new planted trees in Hormare Recreation ground, have been vandalised. The canes and plastic
protective covers have been taken out and thrown all over the Recreation ground. We have replaced the
damaged canes and tubes and a social media post has been posted condemning the behaviour.

Mother and Toddler Group:

• Visited the group and spoke to some of the Mums as well as arranging the group to have a stall at the Funday.

Dog Behaviourist Event:

We hosted the Dog Behaviourist Event at Sullington Warren in partnership with Bone Canis Dog Behaviour
and training services. We met with lots of dog walkers; it was very busy due to the good weather.
The dog walkers are able to allow their dogs to socialise with each other in a friendly and safe environment.
Training and behaviour tips are well received form the dog owners. Big thanks to Mark (Owner of Bone
Canis) for his support and enthusiasm at our events.





Storrington Library:

• We met with the new Well Being Officer who is responsible for the library staff across West Sussex. We gave him an introduction of what we do, how we report low level ASB and the issues within Storrington and Sullington. In turn he informed us of what he looks into E.G: ASB at Libraries, difficult customers and any verbal or physical abuse his staff may incur. We recommended that he speaks with our colleagues at the other Parishes.

Village Market:

- We visited the market this month (04.04.2025). Very busy, everyone in good spirits.
- Very busy at the Village Market today (11.04.2025). Updated residents on up-and-coming events, particularly the Bingo event to be held at Hanover Walk.
- Met resident and discussed personal attack alarms as resident is concerned.

Journey, Autism and SEN (Special educational needs) Group:

• Held our monthly event which was well supported. The youth that attended was telling everyone about his trip to the imperial war museum. The recall from him was marvellous.

Autism and SEN weekly all sports event:

- First one after the Easter break. The new sensory Dome was a big hit and to our surprise we had sixteen kids attend. 23/4/25.

- We have started to highlight areas (pavements etc.) around the Parish that need attention by either
 Horsham District Council (HDC) or West Sussex County Council (WSCC). We will send on any information to
 HDC directly and pass on any other repairs to one of our Councillors who will consult directly with WSCC.
- We have identified more pavement issues which have been reported to our Parish Councillor.

Encampment:

• Reported breach of planning regulations to Parish Council. Static homes have been set up on land off Fryern Road.

School Engagement:

- Attended Rock Road school for a lunchtime meet and greet with Staff and pupils.
- Engaged with Storrington Primary School staff due to an Ice Cream Van parking on double yellow lines
 opposite the school. The Van moved on to Chanctonbury Leisure Centre Car Park and we witnessed them
 trading. We informed the owner of the van that he did not have permission to trade on Parish property and
 asked him to leave. He did without any problems.

Hazards and Risks:

- Reported to HDC damaged path on Riverwalk.
- Reported another damaged path on Riverwalk.
- Reported to HDC damage to path along Riverwalk. This is the second time this has been reported.

- Reported one of the containers in Hormare recreation ground to Parish council. This is not connected to the
 football club as it has mains electricity and vents. There was a faint smell of gas. Have given details from
 corporate mapping that it is marked as Gov Gas.
- Reported pavement trip hazards at Place Villerest and Mill Lane to HDC again.
- We reported hazards on footpaths in various locations across the Village. Some will be dealt with by Horsham District Council and some by West Sussex County Council.


