Anti-Social Behaviour

Through our partnership working, in particular with Sussex Police and Neighbourhood Watch Association, plus routine monitoring of crime reporting websites for information about suspicious activity, people and vehicles we are able to understand and respond to emerging trends.

05/02 and 12/02 – We received a report of a group of young people getting access to a residential block in Lintot Square and running around the corridors banging on doors and ringing doorbells. Please discourage your children from doing this as there are always some residents who are more vulnerable than others and this could cause them considerable distress. We have undertaken letter drops to Lintot Court, The Wickens and Kilner Court providing guidance and contact details to help address future issues. We have looked at CCTV and when suspects are identified they will be spoken to.

Parking/vehicles

02/02 – Whilst on patrol we had to undertake traffic management outside the petrol station at school pick up time due to the additional build-up of vehicles resulting from the temporary traffic lights outside The Lintot. Please make sure that you can complete your manoeuvre before cutting across traffic and be considerate of other road users.

07/02 and 12/02 – We received reports from two residents in relation to vehicle related anti-social behaviour of a neighbour who has a noisy exhaust who allegedly, particularly early in the morning, revs their engine repeatedly. They also allegedly park across the entire pavement and tailgate people in the road. Advice was provided about Operation Crackdown and we will be monitoring the situation and will take enforcement action if appropriate.

03/02 – Whilst on patrol in the Christs Hospital area one evening, we noticed a suspicious vehicle with no MOT which may have been involved in rural and wildlife crimes. Using our established links with the police, we were able to pass this information to their Rural Crime Team for further investigation.

12/02 – We received a report from a concerned resident about the damage being caused to the soft grass verge under the bridge on Blakes Farm Road where vehicles have been parking. On 16/02 we instructed the driver of a delivery vehicle parked there to move to a more appropriate location.

27/02 – We spoke to the driver of a sign written van parked on Fairbank Road obstructing two junctions and causing chaos with the queuing traffic at the temporary traffic lights. The driver was having their lunch and when asked to move became verbally aggressive before telling us to issue a ticket. So, we did!

Patrols

- We continue patrols of local businesses designed to disrupt shoplifting, ASB and improve engagement.
- We continue to provide high visibility patrols both on foot and in a liveried vehicle throughout the Parish.

Older, Vulnerable People and Youth

We routinely conduct high visibility patrols at times and in areas often used by older residents to offer a reassuring presence plus cover areas previously connected with ASB in order to act as a deterrent. Throughout the month, we regularly visited the Southwater Youth Project and engaged with many young people.

02/02 – We were approached by a family who were really struggling with the increased cost of living expenses and were able to support them to get a crisis food parcel and provide contact details for local support services.

03/03 – Whilst on patrol we noticed a young adult searching a stretch of pavement outside Roundstone Caravan Park in the dark with only a phone for light. We joined them in the search for their missing glasses which had been lost while jogging. If you have found any, please let us know.

27/02 – We provided hot water in flasks to some residents who were affected by the power cut caused by a fallen tree on powerlines outside their properties. Some were unable to make hot drinks to keep warm, so these flasks were greatly appreciated by the residents. Some of the flasks were kindly donated to us by Caroline Paul who is the Coop Member Pioneer for Southwater and Rudgwick Stores COOP for use in such incidents.

28/02 – Following reports from a concerned member of the public, we visited a local resident and RAF veteran in their 90s who lives independently but has been suffering with the negative impact of isolation. We were privileged to be invited into their home so we could talk about some of the suitable activities and support groups that may be accessible in the village. If you know of free, in person befriending services or organisations which you feel could support them particularly with local transport to clubs, then please get in touch with us.

This service provides advice, information and support for people affected by mental health problems, as well as carers, friends and professionals. 26/02 – We were first on scene to a tree that had fallen onto powerlines and blocking the road on Old House Lane. Road closures were put in place whilst we liaised with Sussex Police, UK Power Network & West Sussex County Council to alert them to the incident and coordinate repairs.
